### Clinical Opportunities:

- Interested in issues of police violence? The [Community Group Advocacy and Social Change Lawyering Clinic](#) is designed for students interested in social change lawyering and working as partners with activist community groups pressing for social change. **In Spring 2017, projects will focus on issues of police violence.** The Clinic explores “rebellious” or “democratic” approaches to lawyering and the range of tools and strategies social change lawyers utilize, including grassroots lobbying, legislative drafting, community organizing/mobilizing, community legal education, media campaigns, and/or convening public hearings. Students work in two- or three-person teams and are placed with Bay Area social justice lawyers or community groups to work 16-20 hours a week on a defined project. Collectively, projects introduce students to the range of approaches to making social change and to working as partners *with* community groups, rather than navigating the legal system *on their behalf*. Past students' perspectives and projects are available on the clinic's webpage. **To apply, complete the [Common Clinic Application](#) and email [piomelli@uchastings.edu](mailto:piomelli@uchastings.edu) to arrange a time to meet.**
- Interested in Environmental Law? Through the [Environmental Law Clinic](#) field placement, students receive academic credit for work with nonprofit environmental groups and government agencies and gain hands-on experience in environmental practice. For more information see the Clinic's webpage and follow the [link](#) to field placement possibilities. **If you are offered a placement, contact Assoc. Dean Ascanio Piomelli, [piomelli@uchastings.edu](mailto:piomelli@uchastings.edu), and Ms. Theresa Hoskins-Ford, [hoskinsf@uchastings.edu](mailto:hoskinsf@uchastings.edu), for permission to enroll.**
- [Immigrants' Rights Clinic](#) students work directly with clients facing immigration problems including defense against removal proceedings, asylum, nonimmigrant and immigrant visas, and citizenship questions. Students may also participate in policy reform projects on immigration and related issues. **To apply, complete the [Common Clinic Application](#) and email [boswellr@uchastings.edu](mailto:boswellr@uchastings.edu).**
- Interested in law, public policy, and politics? Consider enrolling in the [Legislation Clinic](#) field placement program and working full-time in Sacramento for the Legislature (part-time opportunities may be available). Students are placed with a member of the Legislature, a legislative committee in a subject area of the student's interest, or with the Legislative Counsel, to learn first-hand about the statutory law making process. The clinic focuses on the practice skills of legal writing, negotiation, and advocacy. Concurrent instruction is provided in Sacramento. A full-time student will earn a total of 13 units. A Legislative Process mini-course for 1 unit may be offered and required of all students who have not taken Legislative Process, also taught in Sacramento (for a total of 14 units). - Interested in Local Government? In the [Local Government Clinic](#) field placement program, you can work and learn at a Bay Area City Attorney's Office or County Counsel's office, while being supported by your professor and your peers in the clinic's course component. Your experience can give you the chance to build relationships with mentors who can advise and support you as you embark on your career. Local governments' actions impact every aspect of their residents' lives, and government lawyers find themselves involved in every important public issue. You might help advise a city agency on an issue of constitutional law, or draft an ordinance involving in telecommunications law, health law or employment law. You might help represent your city in court or in a code enforcement proceeding, or help advise a city commission at a zoning hearing. In the clinic's course component, you'll review important principles of local government law, learn about the ethical responsibilities of lawyers who represent local governmental agencies, and work to improve your research and writing skills. - Want to hone your public speaking and conflict resolution skills while helping people resolve ongoing disputes? Join the [Mediation Clinic](#) and serve as a neutral third party for the San Francisco Small Claims Court and State and City/County agencies. Working in two-person teams under faculty supervision, students mediate a wide variety of civil cases,

including: landlord-tenant, creditor-debtor, commercial, consumer, property, and auto accidents. Through the Clinic's partnerships with the CA Dept. of Fair Employment and Housing and the SF Human Rights Commission, student-mediators also mediate discrimination complaints in employment, housing, and public accommodations. To prepare for this fieldwork, students learn relevant law and procedure, receive extensive training in mediation theories and techniques, apply bias reduction strategies, and analyze ethical, policy, and practice issues in the twice-weekly seminar. Mediators engage in thorough debriefing sessions, write reflection papers, and receive detailed feedback from faculty and classmates. Students also shadow a professional mediator as part of the Mediation Observation Program of the Center for Negotiation and Dispute Resolution. **To apply, use the [Common Clinic Application](#) and email Prof. Gail Silverstein, [silverst@uchastings.edu](mailto:silverst@uchastings.edu).** An information session will be held on Wednesday, Nov. 16 from 3:30-4:30 in Room 325 of the Tower (small seminar room outside our Community Justice Clinics).

- In the [Medical-Legal Partnership for Seniors Clinic \(MLPS\)](#), law students work with medical professionals to offer holistic legal services to low-income older adult UCSF and VA patients. Students meet with patients on-site at a medical clinic and in patient homes and advise and advocate across multiple areas of law, including advance health care planning, estate planning, public benefits, and pre-eviction housing. Students develop key lawyering skills in interviewing, counseling, critical thinking, document drafting, project management, interdisciplinary collaboration, and "whole person" lawyering through the representation of multiple clients from start to finish. The seminar engages students in thoughtful discussion and practice-based learning about advance planning, public benefits, interdisciplinary ethics, how to evaluate client capacity, long-term care options, elder abuse, and other issues. Students learn about the complex intersection of law and health and its implications for our rapidly aging population. No prereqs or special experience required. - Students interested in Employment Law should consider the [Workers' Rights Clinic](#). The Clinic provides free legal information and assistance to low-income workers with employment-related issues. The Employment Law Center of the Legal Aid Society of San Francisco trains and supervises students who conduct client interviews and, after consultation with clinic coordinators, provide counseling, legal information, and referrals to workers on a full range of employment-related problems. Older editions of casebooks tend to be cheaper, but new editions of casebooks tend to include revised legal principles and updated footnotes.
