



SUMMER PUBLIC INTEREST EMPLOYMENT LOAN PROGRAM APPLICATION

The UC Hastings Summer Public Interest Employment Loan was established to provide a living subsidy through a \$4000 loan to a limited number of rising 2L and 3L students who will work for a government or non-profit institution in a non-paid summer position.

ELIGIBILITY REQUIREMENTS

To be eligible for this loan, you must:

- Be a UC Hastings 1L or 2L student;
- Be eligible for need-based financial aid;
- Have secured an unpaid internship at a government or non-profit institution this summer;
- Be *credit-worthy* – UC Hastings will request a credit report from a national credit bureau to assist in determining credit-worthiness and loan disbursements will be reported to a credit bureau; and
- NOT be enrolled in summer classes; and
- NOT have received an HPILF grant, UC Hastings International Summer Stipend, and/or summer scholarship to which you applied through UC Hastings.

CHARACTERISTICS OF THE LOAN

- Annual interest rate of 5%;
- Five year repayment period;
- Nine month grace period after separation from UC Hastings;
- No interest accrual until the first day of the repayment period; and
- NOT eligible for forgiveness through PICAP or the Federal Public Service Loan Forgiveness program.

APPLICATION PROCESS

Applications will be reviewed by a committee of UC Hastings staff and faculty. Decisions will be made as soon as possible, but loans will not be disbursed until mid-June.
