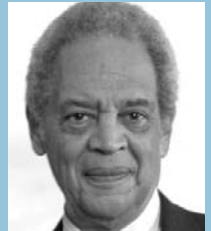

Recognized by *Scientific American* as one of the country's Top 50 Visionaries, Lessig (who is also known as the Elvis of cyberlaw) is a Professor of Law at Stanford Law School. His most recent book is entitled: *Remix: Making Art and Commerce Thrive in the Hybrid Economy*.

ROGER WILKINS / APRIL 16, 2009

At the age of 33, Wilkins became the highest-ranking African American in President Lyndon Johnson's Justice Department. (Martin Luther King, Jr., once referred to him as the "Leader of the Civil Rights Movement inside the U.S. government".) After he left the government, Wilkins served on the editorial boards of both the *Washington Post* (where he won a Pulitzer Prize) and the *New York Times*. He also wrote two highly acclaimed books, made two documentaries, and for more than two decades taught history and American culture at George Mason University.
